Public schools to provide feminine hygiene products.

A BILL

for

1 AN ACT relating to school districts; requiring school
2 districts to provide feminine hygiene products in restrooms
3 as specified; providing an appropriation; and providing for
4 an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 21-3-110(a)(xliv) is amended to read:

9

10 **21-3-110. Duties of boards of trustees.**

11

12 (a) The board of trustees in each school district
13 shall:

14

1 (xliv) Ensure that each school district in the
2 state requires every multiple occupancy restroom, changing
3 room or sleeping quarters be designated for the exclusive
4 use of the male sex or the exclusive use of the female sex.

5 Effective school year 2026-2027 and each school year
6 thereafter, the board of trustees shall ensure that an
7 adequate supply of feminine hygiene products are available
8 free of charge in each restroom that is designated for the
9 exclusive use of the female sex and that is regularly used
10 by students. The board of trustees shall inform public
11 school students of the availability and location of
12 feminine hygiene products under this paragraph. As used in
13 this paragraph, "feminine hygiene products" means tampons,
14 sanitary napkins or other similar products designed for
15 hygiene in connection with the human menstrual cycle.

17 **Section 2.**

19 (a) There is appropriated four hundred eighty seven
20 thousand five hundred dollars (\$487,500.00) from the public
21 school foundation program account to the department of
22 education-school finance to provide funding to school
23 districts to provide feminine hygiene products as required

1 by section 1 of this act for school years 2026-2027 and
2 2027-2028. School districts shall be reimbursed based on
3 actual costs to provide feminine hygiene products and
4 dispensers that are submitted to the department of
5 education-school finance, subject to the following
6 limitations:

8 (i) For school year 2026-2027, no school
9 district shall be reimbursed more than one thousand one
10 hundred dollars (\$1,100.00) for every one hundred female
11 students in grades six (6) through twelve (12) for the
12 costs of providing feminine hygiene product dispensers and
13 supplies;

14

15 (ii) For school year 2027-2028, no school
16 district shall be reimbursed more than eight hundred fifty
17 dollars (\$850.00) for every one hundred female students in
18 grades six (6) through twelve (12) for the costs of
19 providing feminine hygiene product supplies.

20

21 (b) The appropriation under subsection (a) of this
22 section shall be for the period beginning with the
23 effective date of this act and ending June 30, 2028. This

1 appropriation shall not be transferred or expended for any
2 other purpose and any unexpended, unobligated funds
3 remaining from this appropriation shall revert as provided
4 by law on June 30, 2028. It is the intent of the
5 legislature that the appropriation in this section be
6 included in the standard budget of the department of
7 education-school finance for the immediately succeeding
8 fiscal biennium.

9

10 **Section 3.** This act is effective July 1, 2026.
