A BILL

for

1 AN ACT to make appropriations for the fiscal biennium commencing July 1, 2026  
2 and ending June 30, 2028; providing definitions; providing for appropriations  
3 and transfers of funds for the period of the budget and for the remainder of  
4 the current biennium ending June 30, 2026 as specified; providing for  
5 carryover of certain funds beyond the biennium as specified; providing for  
6 employee positions as specified; providing for duties, terms and conditions  
7 and other requirements relating to appropriations for the remainder of the  
8 current biennium ending June 30, 2026 and the period of the budget as  
9 specified; providing for position and other budgetary limitations; amending  
10 existing law by redirecting revenues for the period of the budget; continuing  
11 an account; authorizing loans; discharging interfund loans; increasing higher  
12 education scholarship amounts for the fiscal biennium commencing July 1, 2026  
13 and ending June 30, 2028; making conforming amendments; amending and  
14 repealing prior appropriations; and providing for effective dates.

16 *Be It Enacted by the Legislature of the State of Wyoming:*

17

18 **Section 1.** As used in this act:

19

1 (a) "Agency" means any governmental unit or branch of government  
2 receiving an appropriation under this act;

3

4 (b) "Appropriation" means the authorizations granted by the  
5 legislature under this act to make expenditures from and to incur obligations  
6 against the general and other funds as specified;

7

8 (c) "Approved budget" means as defined by W.S. 9-2-1002(a)(xxiii);

9

10 (d) "A4" means an agency trust account;

11

12 (e) "EF" means the agency's account within the enterprise fund;

13

14 (f) "FF" means federal funds;

15

16 (g) "IS" means the agency's account within the internal service fund;

17

18 (h) "PF" means the retirement account created by W.S. 9-3-407(a);

19

20 (j) "PR" means private funding sources;

21

22 (k) "P2" means the deferred compensation account referenced in W.S.  
23 9-3-507;

24

25 (m) "SR" means an agency's account within the special revenue fund;

26

1 (n) "S1" means water development account I created by W.S.  
2 41-2-124(a)(i);

3

4 (o) "S2" means water development account II created by W.S.  
5 41-2-124(a)(ii);

6

7 (p) "S4" means the local government capital construction account  
8 funded by W.S. 9-4-601(a)(vi) and (b)(i)(A) and 39-14-801(e)(ix);

10 (q) "S5" means the "school foundation program account" or "public  
11 school foundation program account" created by W.S. 21-13-306(a);

13 (r) "S7" means the highway fund;

14

15 (s) "S10" means the legislative stabilization reserve account;

16

17 (t) "S13" means the strategic investments and projects account;

18

19 (u) "S14" means the Wyoming tourism account;

20

21 (w) "S0" means other funds identified by footnote;

23 (y) "T2" means the miners' hospital permanent land income fund;

25 (z) "T3" means the state hospital account within the permanent land  
26 fund;

1           (aa) "T4" means the poor farm account within the permanent land fund  
2 as established by W.S. 9-4-310(a)(v);

4           (bb) "T0" means other expendable trust funds administered by an agency  
5 for specific functions within the agency's authority;

7           (cc) "TT" means the tobacco settlement trust income account;

9           (dd) "This appropriation," when used in a footnote, shall be construed  
10 as a reference to that portion of the appropriated funds identified in the  
11 footnote.

13           **Section 2.** The sums of money, or so much thereof as is necessary,  
14 appropriated in this act are to be expended during the two (2) years  
15 beginning July 1, 2026 and ending June 30, 2028, or as otherwise specified,  
16 for the purposes, programs and number of employees specified in this act and  
17 the approved budget of each agency. Unless otherwise specifically provided,  
18 the conditions, terms and other requirements on appropriations in this act  
19 are effective until June 30, 2028, subject to accrual accounting principles.

 20 (\$250,000.00) shall only be available for expenditure if there is a change of  
 21 governor as a result of the 2026 general election. This appropriation is for  
 22 transition staff salaries, travel, expenses incurred in relocating to and  
 23 from the governor's mansion and other related office expenses, except that up  
 24 to twenty thousand dollars (\$20,000.00) of this appropriation may be expended

 4 for any one (1) appointee. It is the intent of the legislature that this  
 5 appropriation not be included within the office of the governor's standard  
 6 budget for the immediately succeeding fiscal biennium. This appropriation  
 7 shall not be transferred or expended for any other purpose.

8  
 9 2. (a) Authorization for up to two (2) at-will employee contract positions  
 10 supported by funds originating from section 9901 of the American Rescue Plan  
 11 Act of 2021, P.L. 117-2, shall remain effective until the latter of:

 13 (i) December 31, 2026;

 15 (ii) The date of completion of any federally required reporting  
 16 and audits; or

 18 (iii) The date of any extension of federal expenditure deadlines  
 19 under section 9901 of the American Rescue Plan Act of 2021, P.L. 117-2,  
 20 enacted into law.

 22 3. (a) This general fund appropriation shall be deposited into the federal  
 23 natural resource policy account. All funds within the federal natural

13 4. It is the intent of the legislature that this appropriation not be  
 14 included in the office of the governor's standard budget for the immediately  
 15 succeeding fiscal biennium. This appropriation is effective immediately.

18 (b) Nothing in this footnote should be construed to modify the maximum  
 19 annual salary limits provided in W.S. 9-1-409(j).

20

21 2. A portion of this other funds appropriation may be expended to conduct  
 22 the purposes of this footnote. In accordance with W.S. 9-1-205(a), the state  
 23 treasurer's office shall annually provide a public accounting of the direct,

 10 department of administration and information include any requested amount for

 20 to the 2024 market pay tables, this appropriation shall not be effective.

## [BUDGET BALANCERS - TRANSFERS]

**Section 300.**

(a) The state auditor shall transfer any unappropriated funds in the general fund on June 30, 2026 in excess of one hundred ninety-two million seven hundred sixty-five thousand dollars (\$192,765,000.00) to the legislative stabilization reserve account.

(b) The state auditor shall transfer a total of one hundred thirty-eight million nine hundred seventy-four thousand six hundred eighty-eight dollars (\$138,974,688.00) from the strategic investments and projects account to the general fund in one (1) or more transfers. Any amounts transferred to the general fund under this subsection prior to June 30, 2026 shall be exempt from the transfer of funds to the legislative stabilization reserve account as required by 2024 Wyoming Session Laws, Chapter 118, Section 300(b). This subsection is effective immediately.

(c) The state auditor shall transfer forty-four million three hundred forty-eight thousand one hundred thirty-one dollars (\$44,348,131.00) from the general fund to the legislative stabilization reserve account.

## [BORROWING AUTHORITY - CASH FLOW AND EXECUTIVE PROGRAMS]

**Section 301.**

1 (a) The state auditor is authorized to borrow from the legislative  
2 stabilization reserve account amounts necessary to assist the state's general  
3 fund cash flow. The amounts borrowed shall be repaid when sufficient general  
4 fund revenue is available. The auditor shall borrow funds under this  
5 subsection only to assist the month-to-month cash flow of the general fund
