6 Be It Enacted by the Legislature of the State of Wyoming:

- 8 **Section 1.** W.S. 42-4-106 by creating a new subsection
- 9 (e) is amended to read:

- 11 42-4-106. Application for assistance; determination
- 12 of eligibility; assignment of benefits; resources and
- 13 income allowances defined for institutionalized spouse.

1 (e) The following requirements shall be met before an applicant is eligible for medical assistance under this 2 3 chapter: 4 5 (i) An applicant shall be a citizen or national of the United States and shall provide a valid social 6 7 security number and proof of identity. An applicant 8 considered to be lawfully present in the United States shall be eligible for medical assistance under this 9 10 chapter; 11 12 (ii) An applicant shall be a Wyoming resident or 13 meet the criteria specified in the Wyoming Medicaid state plan. An applicant who intends to return to the applicant's 14 home in another state or country shall not be considered a 15 16 Wyoming resident; 17 (iii) An applicant shall fulfill not less than 18 19 one (1) of the following criteria: 20 21 (A) Be determined disabled according to social security guidelines by the social security 22 administration or the department; 23

2	(B) Be entitled to receive supplemental
3	security income or be eligible for supplemental security
4	<pre>income-related programs;</pre>

6	(C) Be entitled to receive hospice services
7	in accordance with a voluntary election and a health care
8	provider statement of a terminal condition where:

10	(I) The applicant has received hospice
11	services or resided in a medical institution for not less
12	than thirty (30) consecutive days; or

14	(II) The applicant is not a
15	supplemental security income recipient and dies before
16	completion of the time requirement specified in subdivision
17	(I) of this subparagraph.

19	(D) Be qualified for services under a
20	Medicaid waiver that the legislature has authorized
21	pursuant to department rules;

23	(E) Be infected with tuberculosis;

1 2 (F) Be otherwise qualified for medical 3 assistance pursuant to federal Medicaid regulations or be 4 eligible under a mandatory requirement of the federal government for participation in Medicaid, provided that no 5 6 expansion eligibility for Medicaid beyond the eligibility 7 as of July 1, 2026 shall occur without prior authorization 8 by the legislature. 9 10 (iv) An applicant shall fulfill any other 11 criteria required pursuant to rules of the department or 12 federal Medicaid regulations. 13 Section 2. The department of health shall promulgate 14 all rules necessary to implement this act not later than 15 October 1, 2026. 16

Section 3. This act applies to applications for medical assistance submitted or renewed on or after July 1, 20 2027.

4 section, this act is effective July 1, 2027.

7 immediately upon completion of all acts necessary for a
