## A BILL

for

- 1 AN ACT relating to defense forces and affairs; increasing

- 5 making conforming amendments; providing an appropriation;
- 6 and providing for an effective date.

8 Be It Enacted by the Legislature of the State of Wyoming:

- 10 **Section 1**. W.S. 19-9-403(e)(intro), (i), (ii),
- 11 (iv)(B) and (v) is amended to read:

- 13 19-9-403. Pay and allowances of officers and enlisted
- 14 persons in active state service and state active duty;

- 1 worker's compensation coverage for national guard members;
- 2 no pension denied by reason of service.

4 (e) There is created the Wyoming national guard member referral incentive program. The purpose of the 5 program shall be to incentivize and maximize peer-to-peer 6 recruiting that results in a completed accession to the 7 8 Wyoming national guard by providing a referral bonus to Wyoming national guard members, veterans of the Wyoming 9 10 national guard, current employees of the military 11 department or recruits beginning the enlistment process 12 with the Wyoming national guard who make a successful referral. Administration of this program shall require 13

that:

16 (i) A Wyoming national guard member, veteran of 17 the Wyoming national guard, current employee of the military department or recruit beginning the enlistment 18 19 process with the Wyoming national guard may provide the 20 identity and contact information of a person who the member, veteran, employee or recruit believes would be an 21 appropriate recruitment prospect using a form provided by 22 the Wyoming national guard, which includes the person's 23

2 Section 2. There is appropriated one 3 sixty-three thousand dollars (\$163,000.00) from the general 4 fund to the Wyoming military department for purposes of 5 making referral bonus payments authorized by W.S. 19-9-403(e), as amended by this act. This appropriation 6 shall be for the period beginning with the effective date 7 8 of this act and ending June 30, 2028. This appropriation shall not be transferred or expended for any other purpose 9 10 and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 11 12 2028. It is the intent of the legislature that this appropriation not be included in the standard budget for 13 Wyoming military department for the immediately 14 the succeeding fiscal biennium. 15

17 Section 3. This act is effective July 1, 2026.
