- 6 requirements; and providing for an effective date.

- and (q) and 31-5-952 (d) are amended to read:

- 13 31-5-224. Operation of vehicles upon approach of
- 14 authorized emergency vehicles and other parked or

(b) When an authorized municipal, public utility or highway construction or maintenance vehicle is stopped or is moving at less than twenty (20) miles per hour on or within three (3) feet of a roadway and is making use of any visual signals provided for in W.S. 31-5-928(d), (f) (ii) and (iii), (h) or 31-5-930, the driver of every other vehicle, as soon as it is safe:

13 (f) The following vehicles are authorized to display
14 flashing white and amber lights in addition to those
15 otherwise authorized by law:

17 (iii) Wreckers, roadside service and tire repair

20 (g) In addition to these lights otherwise authorized 21 by law, a wrecker, roadside service or tire repair vehicle 22 is authorized to display flashing red and blue lights at

(d) Every authorized emergency vehicle, except 6 7 wreckers, roadside service and tire repair vehicles, shall 8 be equipped with a siren, whistle or bell, capable of 9 emitting sound audible under normal conditions from a distance of not less than five hundred (500) feet and of a 10 11 type approved by the superintendent, but the siren shall 12 not be used except when the vehicle is operated in response 13 to an emergency call or in the immediate pursuit of an actual or suspected violator of the law, in which case the 14 15 driver of the vehicle shall sound the siren when reasonably 16 necessary to warn pedestrians and other drivers of the
