A BILL

for

1 AN ACT relating to water development projects; authorizing
2 construction of designated water projects; describing
3 projects; specifying terms and conditions of funding for
4 projects; providing grants; providing loans; providing
5 appropriations; amending amounts and terms of
6 appropriations for specified prior projects; transferring
7 funds from water development account I to water development
8 account II; transferring a project; requiring a study;
9 requiring a report; and providing for an effective date.

11 *Be It Enacted by the Legislature of the State of Wyoming:*

12

13 **Section 1.** W.S. 99-3-3101 through 99-3-3104 are
14 created to read:

3 **99-3-3101. Definitions.**

4

5 The definitions in W.S. 99-3-101 apply to this article.

6

7 **99-3-3102. General authorization.**

8

9 The provisions of W.S. 99-3-102 apply to this article.

10

11 **99-3-3103. Level III construction projects - new**
12 **development.**

13

14 (a) Authorization is granted for the Level III new
15 development construction projects identified in this
16 section subject to the general conditions specified in W.S.
17 99-3-103, provided that W.S. 99-3-103(a)(iii) shall not
18 apply to the projects identified in this section unless
19 required by W.S. 41-2-121.

20

21 (b) Project - Alpine Well #4 Transmission Pipeline
22 2026:

23

1 (i) Project sponsor: Town of Alpine;

2

3 (ii) Project purpose: Municipal water supply;

4

5 (iii) Project description: Design and
6 construction of water transmission pipeline, structures and
7 appurtenances necessary to make the project function in the
8 manner intended;

9

10 (iv) Total project budget: Four hundred twenty
11 thousand dollars (\$420,000.00);

12

13 (v) Project grant: The state of Wyoming shall
14 grant to the sponsor from water development account I
15 through the commission for the design, permit procurement,
16 project land procurement, construction engineering and
17 construction of the project an amount not to exceed two
18 hundred ten thousand dollars (\$210,000.00) or fifty percent
19 (50%) of these actual development costs, whichever is less;

20

21 (vi) Appropriations: There is appropriated from
22 water development account I to the commission two hundred
23 ten thousand dollars (\$210,000.00) or as much thereof as is

1 necessary to carry out the purpose of this subsection.
2 Unexpended funds appropriated under this subsection shall
3 revert to water development account I on July 1, 2031;

4

5 (vii) Special conditions: The sponsor is
6 responsible for acquiring fifty percent (50%) of the total
7 project budget from other sources.

8

9 (c) Project - Cloud Seeding: Wind River and Sierra
10 Madre mountain ranges 2027 (ground-based):

12 (i) Project sponsor: The state of Wyoming;

13

14 (ii) Project purpose: To enhance the winter
15 snowpack in the Wind River and Sierra Madre mountain
16 ranges;

17

18 (iii) Project description: Conduct a
19 ground-based operational winter snowpack augmentation
20 program during the 2026-2027 season;

21

1 (iv) Total project budget: Eight hundred
2 ninety-one thousand four hundred twenty-nine dollars
3 (\$891,429.00);

4
5 (v) Special conditions: Prior to commencing
6 project operations, the Wyoming water development office
7 shall acquire funding commitments from other Colorado River
8 basin water users or other interested parties for a minimum
9 of one hundred percent (100%) of actual project operations
10 costs.

14 (i) Project sponsor: City of Gillette;

15
16 (ii) Project purpose: Municipal water supply;

17
18 (iii) Project description: Construction
19 engineering and construction of a tank, structures and
20 appurtenances necessary to make the project function in the
21 manner intended;

1 (iv) Total project budget: Five million one
2 hundred nineteen thousand dollars (\$5,119,000.00);

3
4 (v) Project grant: The state of Wyoming shall
5 grant to the sponsor from water development account I
6 through the commission for the construction engineering and
7 construction of the project an amount not to exceed two
8 million five hundred fifty-nine thousand five hundred
9 dollars (\$2,559,500.00) or fifty percent (50%) of these
10 actual development costs, whichever is less;

11
12 (vi) Appropriations: There is appropriated from
13 water development account I to the commission two million
14 five hundred fifty-nine thousand five hundred dollars
15 (\$2,559,500.00) or as much thereof as is necessary to carry
16 out the purpose of this subsection. Unexpended funds
17 appropriated under this subsection shall revert to water
18 development account I on July 1, 2031;

19
20 (vii) Special conditions: The sponsor is
21 responsible for acquiring fifty percent (50%) of the total
22 project budget from other sources.

3 (i) Project sponsor: Town of LaGrange;

7 (iii) Project description: Design and
8 construction of a well connection, well treatment, pumping
9 facilities, transmission pipelines, structures and
10 appurtenances necessary to make the project function in the
11 manner intended;

12

13 (iv) Total project budget: Seven hundred forty
14 thousand dollars (\$740,000.00);

15

16 (v) Project grant: The state of Wyoming shall
17 grant to the sponsor from water development account I
18 through the commission for the design, permit procurement,
19 project land procurement, construction engineering and
20 construction of the project an amount not to exceed three
21 hundred seventy thousand dollars (\$370,000.00) or fifty
22 percent (50%) of these actual development costs, whichever
23 is less;

1

2 (vi) Appropriation: There is appropriated from
3 water development account I to the commission three hundred
4 seventy thousand dollars (\$370,000.00) or as much thereof
5 as is necessary to carry out the purpose of this
6 subsection. Unexpended funds appropriated under this
7 subsection shall revert to water development account I on
8 July 1, 2031;

9

10 (vii) Special conditions: The sponsor is
11 responsible for acquiring fifty percent (50%) of the total
12 project budget from other sources.

19 Conservation District and Savery-Little Snake River Water

1 (iii) Project description: Design and
2 construction of forest management treatments, lake outlet,
3 structures and appurtenances necessary to make the project
4 function in the manner intended;

5
6 (iv) Total project budget: Two million one
7 hundred eighty-four thousand dollars (\$2,184,000.00);

8
9 (v) Project grant: The state of Wyoming shall
10 grant to the sponsor from water development account I
11 through the commission for the design, land access, permit
12 procurement, construction engineering and construction of
13 the project an amount not to exceed one million ninety-two
14 thousand dollars (\$1,092,000.00) or fifty percent (50%) of
15 these actual development costs, whichever is less;

16
17 (vi) Appropriation: There is appropriated from
18 water development account I to the commission one million
19 ninety-two thousand dollars (\$1,092,000.00) or as much
20 thereof as is necessary to carry out the purpose of this
21 subsection. Unexpended funds appropriated under this
22 subsection shall revert to water development account I on
23 July 1, 2031;

1

2 (vii) Special conditions: The sponsor is
3 responsible for acquiring fifty percent (50%) of the total
4 project budget from other sources.

6 (g) Project - Small Water Development Projects - New
7 Development 2026:

9 (i) Project sponsor: Eligible public entities;

10

11 (ii) Project purpose:
12 Multi-purpose - agriculture, recreation and environmental;

13

14 (iii) Project description: Small dams,
15 windmills, springs, guzzlers and other water collection,
16 storage and drinking systems, pipelines, and similar small
17 projects, to impound, develop and convey water for
18 livestock, wildlife, irrigation, environmental and
19 recreational purposes;

20

21 (iv) Total project budget: Two million dollars
22 (\$2,000,000.00);

23

1 (v) Project grant: The state of Wyoming shall
2 grant to sponsors of small water development projects from
3 water development account I through the commission for the
4 design, permit procurement, project land procurement,
5 construction engineering and construction of the project a
6 total amount not to exceed one million dollars
7 (\$1,000,000.00) or fifty percent (50%) of the actual
8 development costs of the small water development projects,
9 whichever is less;

10
11 (vi) Appropriation: There is appropriated from
12 water development account I to the commission one million
13 dollars (\$1,000,000.00) or as much thereof as is necessary
14 to carry out the purpose of this subsection. Unexpended
15 funds appropriated under this subsection shall revert to
16 water development account I on July 1, 2031;

17
18 (vii) Definition: "Small water development
19 project" means a project where the maximum financial
20 contribution from the commission is thirty-five thousand
21 dollars (\$35,000.00) or less;

22
23 (viii) Special conditions:

1

2 (A) The commission may grant a sponsor
3 fifty percent (50%) of the design, permit procurement,
4 project land procurement, construction engineering and
5 construction cost of a small water development project. No
6 grant shall be more than thirty-five thousand dollars
7 (\$35,000.00);

8

9 (B) The small water development project
10 sponsors shall substantiate the public benefit that will be
11 derived from proposed small water development projects;

12

13 (C) The commission may make monthly
14 progress payments of not more than fifty percent (50%) of
15 eligible monthly project expenses;

16

17 (D) An appropriate land management or
18 resource management entity shall certify that the proposed
19 small water development project will meet expectations and
20 that appropriate engineering standards, as approved by the
21 commission, will be adhered to;

22

1 (E) The establishment of criteria and
2 administrative procedures for the development of small
3 water development projects under this subsection and
4 decisions of the commission relating to the
5 recommendations, prioritization or disqualification of
6 small water development projects are specifically exempt
7 from the provisions of the Wyoming Administrative Procedure
8 Act including judicial review under W.S. 16-3-114 and
9 16-3-115;

10
11 (F) W.S. 16-6-116 shall not apply to a
12 small water development project unless the project sponsor
13 determines the small water development project meets the
14 definition of a "public work" as defined in W.S.
15 16-6-101(a)(ix).

21 rehabilitation construction projects identified in this
22 section subject to the general conditions specified in W.S.
23 99-3-104, provided that W.S. 99-3-104(a)(iii) shall not

1 apply to the projects identified in this section unless
2 required by W.S. 41-2-121.

4 (b) Project - Big Horn Canal ID Five Mile Pipeline
5 2026:

7 (i) Project sponsor: Big Horn Canal Irrigation
8 District;

9

10 (ii) Project purpose: Agricultural water supply;

11

12 (iii) Project description: Design and
13 construction of a pipeline, wasteway, structures and
14 appurtenances necessary to make the project function in the
15 manner intended;

16

17 (iv) Total project budget: Four million five
18 hundred forty-four thousand six hundred dollars
19 (\$4,544,600.00);

20

21 (v) Project grant: The state of Wyoming shall
22 grant to the sponsor from water development account II
23 through the commission for the design, permit procurement,

1 project land procurement, construction engineering and
2 construction of the project an amount not to exceed two
3 million two hundred seventy-two thousand three hundred
4 dollars (\$2,272,300.00) or fifty percent (50%) of these
5 actual development costs, whichever is less;

6

7 (vi) Project loan: The state of Wyoming shall
8 loan to the sponsor from water development account II
9 through the commission for the design, permit procurement,
10 project land procurement, construction engineering and
11 construction of the project an amount not to exceed two
12 million two hundred seventy-two thousand three hundred
13 dollars (\$2,272,300.00) or fifty percent (50%) of these

6 through the commission for the design, permit procurement,
7 project land procurement, construction engineering and
8 construction of the project an amount not to exceed two
9 million two hundred twenty-one thousand dollars
10 (\$2,221,000.00) or fifty percent (50%) of these actual
11 development costs, whichever is less;

13 (vi) Project loan: The state of Wyoming shall
14 loan to the sponsor from water development account II
15 through the commission for the design, permit procurement,

18 eighty-two thousand dollars (\$182,000.00) or fifty percent
19 (50%) of these actual development costs, whichever is less;
