Placement	Crisis Care, Foster Care, Therapeutic Foster Care, Group Home, Residential Treatment Centers, Secure Residential Treatment Centers and Psychiatric Treatment.

Assessment – Case assessment is the examination of family or individual problems from the standpoint of safety, risk and need.

Case Management — Services or activities for the arrangement, coordination, and monitoring of services to meet the needs of individuals and families.

Chemical Testing – Random or scheduled urinalysis.

Counseling — Services or activities that apply therapeutic processes to individual, family or situational problems in order to bring about a positive resolution of the problem or improve individual or family functioning or circumstances.

Day Reporting — Service providing daily contact for specific juveniles to assess response to treatment plan expectations.

Day Treatment — Programs for children and youth who are able to remain in their homes, but who have difficulty functioning in their school and community.

Electronic Monitoring — Surveillance and monitoring services for juvenile offenders who have been adjudicated in a juvenile court and placed on supervised probation with DFS.

Evaluation — Diagnostic assessments for an individual or family; may include psychological evaluations, psychiatric evaluations or other clinical diagnostic evaluations.

Family Preservation — Array of services used to maintain an intact family threatened with losing custody of a child or to reunify a child in an out of home placement.

Family Support — A continuum of treatment services which focus on strengthening families so they can meet their own needs.

Home Based Services — A continuum of treatment services which focus on strengthening families so they can meet their own needs.

Independent Living — Services designed to promote and lead a youth's emancipation.

Mentoring — A one-to-one relationship or partnership that focuses on the needs of the mentored participant.

Parenting — An individual or group program that provides education to parents in order to better meet the needs of their children/youth.

Transportation — Travel and related costs only when an integral part of a case plan to gain access to social services or medical care.
