In 2005, The Office of Youth Alternatives received funding in the amount of \$100,000.00 from monies appropriated by the Legislature to provide juvenile probation services in the Municipal and Circuit Court. The monies received were used to defray program costs associated with providing juvenile services to youth through both the Municipal Court for the City of Cheyenne and the Laramie County Circuit Court. Below is a break down of the services provided, the number of juveniles in each program, and the outcome of those services.

PROGRAM AREA:

1. Court Screening:

Purpose:

All non-traffic juvenile cases cited into the Municipal or Circuit Court are reviewed by the Juvenile Screening Committee. Information is gathered from a multi-disciplinary group about the child's past court involvement, school history, family issues and the like. A brief assessment of the juvenile and possible sentencing alternatives are provided to the Court for the Judges review.

2. Probation:

Purpose:

Juveniles are generally placed on probation for a period of 6 months. They are placed on one of three levels of regular probation and/or Intensive Support Probation, after a risk and needs assessment is completed.

3. Work Alternatives (WAP):

Purpose:

This is a supervised community service program. The young people referred to this program are required to work in the community at various work sites. The program is designed to hold participants accountable for their behavior by requiring them to make give something back to the community. The youth generally work from 24 to 48 hours.

4. School Work Alternatives (SWAP):

Purpose:

This program is a cooperative effort between the School District and Youth Alternatives. When juveniles who are suspended from school complete the required number of community service hours, their suspension time is reduced by one day. These hours are also considered as part of a diversion or sentencing alternative by the court.

5. Electronic Monitoring (EMP):

Purpose:

This alternative enables the Court to monitor the movement of the youth ordered to the program. Youth are required to stay home unless other arrangements are made. Youth are generally placed in the program for a period of 30 to 60 days.

6. Juvenile Alcohol and Drug Intervention Program (JADIP):

Purpose:

The program provides services to juveniles who are experiencing drug and alcohol problems. There are two levels to the program:

- Track I: This level involves alcohol education and counseling for first time underage drinkers and their families.
- Track II (Drug Court Model): This level addresses the needs of youth who have committed a first or second substance abuse related offense. Individuals are typically placed in this program after a substance abuse assessment.

7. Drug Screening (Includes all court services):

Purpose:

Random UA tests are regularly conducted on the juveniles placed on probation and in JADIP TII programs.

Note: A positive test indicates the juvenile was using an illegal controlled substance.

8. Juvenile Accountability and Enrichment Program:

Purpose:

This program is an alternative to detention. Individuals ordered to this program are placed on home detention and the Police Department conducts random evening home visits. In addition, individuals ordered to this program are also required to complete supervised community service from 6:00a.m to 2:00 p.m. on Saturday and Sunday. Typical sentences range from 1 to 4 weekends.

Please note that the program statistics may reflect individuals that were in multiple programs. The number of <u>individuals</u> served through the Court Services Division in 2005 totaled 432.

SUMMARY:

As indicated in the above data, 432 youth and families received services during 2005 in the Municipal and Circuit Courts. In addition to the services required to hold the juvenile accountable for his/her actions, other services were available to the juvenile. These services in many cases included assessments, individual, group and family counseling, tutoring, corrective thinking, mentoring, career education and others.

We recently conducted a recidivism review of all 432 cases that appeared in the courts in 2005. We reviewed

the Municipal, Circuit and District records to determine if any of the 2005 cases had returned to court since their services ended at Youth Alternatives. The recidivism rate does not include those juveniles whose cases were dismissed. The figures below, also include juveniles who were referred to the District Attorney or whose probation was revoked, prior to the juvenile completing their program at Youth Alternatives. The following are the results:

It is important to note that 71% of the juveniles who appeared in the Municipal and Circuit Courts have not appeared in District Court since ending services in the lower courts and as indicated only 20% have been convicted of a higher offense. It is also of interest, that many of the juveniles who reappeared in the Municipal or Circuit Court, were charged with minor status offenses like tobacco or curfew violations.
