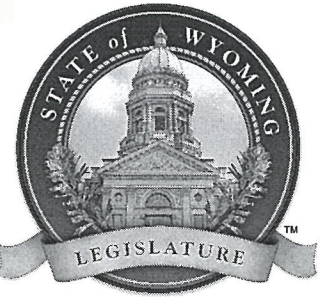


COMMITTEE MEETING ATTENDANCE SIGN IN
