8 **Section 1**. W.S. 18-12-142 is created to read:

1	(a) Except as otherwise provided in this section, a
2	district shall not impose any fee, charge, mill levy, tax
3	or other assessment, or adopt a budget that results in
4	imposition of the same, that when aggregated would create a
5	payment burden on landowners within the district that
6	exceeds any limit stated in the district's original
7	petition for formation on the maximum fee, charge, mill
8	levy, tax or other assessment that may be imposed by the
9	district. A fee, charge, mill levy, tax or other
10	assessment that results in a payment obligation of a
11	landowner shall be calculated as a dollar amount and added
12	with all fees, charges, mill levies, taxes and other
13	assessments, however designated, to determine the total
14	payment burden of the landowner.

(b) Any limitation on the maximum fee, charge, mill 16 17 levy, tax or other assessment that may be imposed by the
