8 **Section 1.** W.S. 26-20-701 is amended to read:

- 10 26-20-701. Required parity for mental health and
- 11 substance use disorder insurance.

1	(a) All individual or group health insurance policies
2	providing coverage on an expense incurred basis, individual
3	and group service or indemnity type health insurance
4	contracts issued by any insurer, including any nonprofit
5	corporation and individual and group service contracts
6	issued by a health maintenance organization, shall meet the
7	requirements of, and the commissioner may enforce subject
8	to the provisions of this section, the Mental Health Parity
9	and Addiction Equity Act of 2008, 42 U.S.C. § 300gg-26, as
10	amended, and the regulations promulgated pursuant thereto
11	as of January 1, 2018. Persons exempt from complying with
12	the Mental Health Parity and Addiction Equity Act shall not
13	be exempted from complying with the requirements of this
14	section if this section otherwise applies to the person.
15	The commissioner may promulgate reasonable rules which
16	establish exemptions from the application of this section.

18 <u>(b) No policy or contract providing mental health or</u>

19 <u>substance</u> use coverage to which subsection (a) of this

20 <u>section applies shall:</u>

1	(i) Deny coverage for mental health or substance
2	use services delivered using remote audio or audio-visual
3	delivery systems to a person not physically present with
4	the delivering health care provider if coverage would be
5	provided for the same services when delivered in person;
6	
7	(ii) Charge a copayment, deductible or
8	coinsurance amount to a person receiving mental health or
9	substance use services through remote audio or audio-visual
10	delivery systems that is higher than the copayment,
11	deductible or coinsurance amount charged for the same
12	services when delivered in person;
13	
14	(iii) Reduce any payment or reimbursement
15	provided to a health care provider using remote audio or
16	audio-visual delivery systems for the provision of mental
17	health or substance use services to an amount that is less
18	than the payment or reimbursement that would be made to a
19	provider rendering those services in person.

1	Section 2. This act shall apply to all policies,
2	plans and contracts delivered, issued, renewed, modified,
3	amended or extended on or after January 1, 2021.
4	
5	Section 3. This act is effective immediately upon
6	completion of all acts necessary for a bill to become law
7	as provided by Article 4, Section 8 of the Wyoming
8	Constitution.
