Selection & Retention

Selection for all Circuit, District and Chancery Court judges, and Supreme Court justices.

- Judicial Nominating Commission
- 3 members elected by Wyoming State Bar, 3 members appointed by the Governor, Chief Justice of Wyoming Supreme Court acts as Chair and votes only in case of tie. Wyo. Const. art. 5, § 4(c) and (e).

Governor appoints judge from 3 nominees submitted by JNC. Wyo. Const. art. 5, § 4(b).

- May be retained or rejected on the ballot in general election. Supreme Court justices every 8 years. Wyo. Const. art. 5, § 4(f). District Court judges every 6 years. Wyo. Const. art. 5, § 4(f). Chancery Court judges every 6 years. Wyo. Stat. Ann. § 5-13-106. Circuit Court judges every 4 years. Wyo. Stat. Ann. § 5-9-109.
- May be removed (or disciplined) by the Wyoming Supreme Court upon recommendation of the Commission on Judicial Conduct and Ethics. Wyo. Const. art. 5, § 6.
- District Court judges and Supreme Court justices (but not Chancery or CircuitCourt judges) must retire at age 70. Wyo. Const. art 5, § 5; Wyo. Stat. Ann. § 5-1-106.

Supreme Court

Appellate jurisdiction, general superintending power over inferior courts.

Wyo. Const. art. 5, § 2,

- General appellate jurisdiction, Wyo. Const. art. 5, § 2; opinions to be in writing, Wyo. Stat. Ann. § 5-2-110.
- Original jurisdiction and power to issue writs. Wyo. Const. art. 5, §3.
- General superintending authority over all inferior courts, including administration of circuit courts, general support to district courts as requested, establishment of chancery court.
- Adopt code of judicial conduct, promulgate rules, and act on discipline on recommendation of the Commission on Judicial Conduct and Ethics, or on its own motion. Wyo. Const. art. 5, § 6.
- Adopt code of attorney ethics and procedure for disciplining, suspending, and disbarring attorneys. Wyo. Stat. Ann. § 5-2-118.
 Act upon the recommendation of the Board of Professional Conduct for attorney discipline, suspension, or disbarment.
- Adopt rules for the practice of law in Wyoming and for the courts. Wyo. Stat. Ann. §§ 5-2-113 117.
- Develop and oversee indigent legal services program. Wyo. Stat. Ann. §§ 5-2-121, 122.
- Install court information technology in all state court facilities. Wyo. Stat. Ann. § 5-2-120.
- Maintain Law Library. Wyo. Stat. Ann. § 5-2-501.
- Maintain Judicial Learning Center.

District Court

Courts of general jurisdiction in all cases unless vested exclusively in some other court, appellate jurisdiction in cases arising from inferior courts.

Wyo. Const. art. 5, § 10

- Legislature enumerates districts, Wyo. Stat. Ann. § 5-3-101, and establishes number of judges for each district. Wyo. Stat. Ann. § 5-3-102(a).
- Judges to hold court for each other. Wyo. Const. art. 5, § 11; Wyo. Stat. Ann. 5-3-106.
- Each judge is supported by 1 court reporter, 1 judicial assistant, and one law clerk.
- Each judge is an agency for budget purposes. Wyo. Stat. Ann. § 5-3-113.
- Courts are housed in county buildings. Wyo. Stat. Ann. § 18-2-103.
- Clerks of district court are elected county officials. Wyo. Stat. Ann. § 5-3-201.
- District courts are "free of administrative and fiscal control by the supreme court," the district court conference governs itself. Wyo. Stat. Ann. § 5-3-102(b).
- Supreme Court IT supports all district court technology, and all court automation systems for the district courts and clerks' offices for integrated statewide system. Wyo. Stat. Ann. § 5-3-102(b).

Chancery Court

Established by statute in 2019 Wyo. Stat. Ann. § 5-13-101

Chancery Court will accept eFiling starting December 1, 2021.

- Court of limited jurisdiction to resolve business disputes with amount in controversy over \$50,000 on an expedited schedule with no jury. Wyo. Stat. Ann. § 5-13-115.
- Concurrent jurisdiction with district courts. Wyo. Stat. Ann. § 5-13-103.
- Up to three Chancery Court judges, same selection, term, and pay as District Court judges. Wyo. Stat. Ann. §§ 5-13-103, 106, 112.
- Three district court judges will serve on an interim basis until March 1, 2023, when the office of Chancery Court judge will be filled. Wyo. Stat. Ann. § 5-13-109.
- Court staff beginning March 1, 2023 will consist of a law clerk, court reporter, judicial assistant for each judge; and a clerk of Chancery Court.
- The Chancery Court clerk is an employee of the Wyoming Supreme Court. Wyo. Stat. Ann. § 5-13-201.
- Will be housed in Casper state office building.
- The Wyoming Supreme Court is "vested with management and supervisory powers" over the Chancery Court. Wyo. Stat. Ann. § 5-13-104(a).

Circuit Court

Established by statute in 2000 Wyo. Stat. Ann. § 5-9-102

- Same boundaries as for district courts.
- Legislature authorizes number of judges, Supreme Court may determine where judge resides based on caseload studies. Wyo. Stat. Ann. § 5-9-103.
- Judges hold court for each other. Wyo. Stat. Ann. 5-9-119.
- Housed in county "quarters." Wyo. Stat. Ann. § 5-9-124.

Unlike district courts, circuit court have limited jurisdiction:

- Less than \$50,000 in civil cases. Wyo. Stat. Ann. § 5-9-128.
- Criminal misdemeanors. Wyo. Stat. Ann. § 5-9-129.
- Small claims, forcible entry and detainer, lien foreclosures (under \$50,000). Wyo. Stat. Ann. § 5-9-128(a).
- Preliminary hearings in felony cases. Wyo. Stat. Ann. § 5-9-132(b).
- Issue warrants. Wyo. Stat. Ann. § 5-9-133(a)(iv).
- Issue domestic violence protective orders. Wyo. Stat. Ann. §§ 35-21-102 et seq.
- Issue stalking and sexual assault orders of protection. Wyo. Stat. Ann. §§ 7-3-506,509.
- Circuit court clerks are employed by the judicial branch. Wyo. Stat. Ann. § 5-9-123.
- Circuit courts are supervised by the Wyoming Supreme Court. Wyo. Const. art. 5, § 2; Wyo. Stat. Ann. § 5-9-107.

Weighted Workload Studies

- Weighted workload studies rely on an assessment methodology that accounts for the varying complexity in different types of court cases – each case type requires different amounts of judicial resources.
 - > Felony cases take more time than Traffic cases.
- The Court contracted with a PhD statistician and court consultant to formulate weighted workload studies beginning in 1999 to more accurately assess the amount of judicial time required for various case types specific to Wyoming, using objective and standardized measures that are periodically updated.
- Applying case weights to current or projected case filing numbers results in an accurate measure of judicial workload across districts.
