			This agency is approved for NIBRS reporting, but were having a major issue with their RMS so they aren't currently reporting. The contact reported they spent a lot of money on their RMS and purchased the module that will allow the system to create the reports for NIBRS. The practice database they used for their testing was different than their live site. This caused many errors with arrest numbers. They had to request their vendor to change how arrest numbers are auto populated as well as to allow the import of Wyoming statutes. This was not an easy process because the system was not working properly, but the agency held the vendor accountable and required them to meet their contracted obligations. At the end of August they had some success working on their January report. On average they have 180 calls per day. The staff member tasked with NIBRS has to review every one of those calls and update their RMS. They also have to manually update each statute for each arrest for the first half of 2021. Now they are short-staffed and while the staff member will continue to work on trying to get 2021 records updated, it will take time. The hope is that once they are caught up to June the statutes will be correct and the process should be a bit smoother and take a

This is not training DCI could provide as we don't know how each RMS works and each agency may have purchased different options of an RMS. The contact said their vendor was going to send someone out to Wyoming to provide training, but that fell through and they feel as though they are at a standstill. The staff member that will work on the NIBRS reporting is feeling overwhelmed with the amount of time it will take combined with her other duties.
