1	(a) In the first annual report due on or after July
2	1, 2023 and annually thereafter, each entity required to
3	file an annual report and pay an annual license fee under
4	this title shall report to the secretary of state the
5	following information from the immediately preceding tax
6	year:

8	(i) Total gross receipts reported for federal
9	tax purposes;

L1	(ii) The portion of gross receipts earned in
L2	Wyoming;

L 4	(iii) The home state of the entity for federal
L5	income tax allocation purposes;

20	(b) Except as otherwise provided in this subsection,
21	all information reported to the secretary of state pursuant
22	to this section shall be kept confidential and shall not be
23	subject to disclosure under the Wyoming Public Records Act

- 1 Upon request, the secretary of state shall submit
- 2 aggregated information without individual identifying
- 3 information to the department of revenue and the joint
- 4 revenue interim committee for the purpose of developing and
- 5 considering legislation.

- 7 (c) The secretary of state shall adopt rules
- 8 necessary to enable collection of the information required
- 9 under subsection (a) of this section and shall make any
- 10 necessary changes to the report form and electronic filing
- 11 system related to the collection of that information. The
- 12 rules shall authorize nonprofit corporations, low profit
- 13 limited liability companies, decentralized autonomous
- 14 organizations and other similar classes of entities that
- 15 the secretary of state determines are not likely to be
- 16 subject to any business franchise tax or similar tax to
- 17 answer "not applicable" to the information that is required
- 18 under subsection (a) of this section.

- 21 of state shall promulgate rules for business franchise tax
- 22 reporting as provided in W.S. 17-27-102(c) created by
