

Why are we doing this brief?

→ County coroners and the Chairmen of JtLHSS requested that the Department of Health examine the potential **costs** and benefits of building a statewide Medical Examiner office, similar to what the State of Montana has established.



- → **Background:** W.S. § 7-4-201 (b) (ii) requires licensed forensic pathologists to perform forensic autopsies throughout the state.
 - ◆ Forensic pathologists can perform both 'regular' autopsies and forensic autopsies.

→ Problem:

- ◆ One forensic pathologist is currently taking on the vast majority of these autopsies.
- ♦ They cannot accommodate the entire workload and some counties contract out of state (Nebraska or Colorado) which increases waiting times.
- ◆ If they were to leave the workforce, all coroners will be forced to contract out-of-state
- Over-utilization of out-of-state forensic pathologists has previously led to "lock-outs"

Autopsies Requested Per Year




Percentage of Decedents Requiring Autopsies

- → 10 out of the 23 counties contract out of state for autopsies:
 - **♦** Laramie

- **♦** Fremont
- **♦** Sweetwater
- **♦** Converse

- ◆ Goshen
- → Laramie, Fremont, Sweetwater, and Albany counties account for roughly 200 autopsies per year, nearly 40% of the state's autopsies in a given calendar year.

Objective




- → Develop an alternative that gives the State "self-sufficiency" when it comes forensic autopsies.
 - ◆ Decreases wait times for coroners and families
 - ◆ Reduces other costs associated with contracting (travel expenses)
 - ♦ Avoids "lock-out" scenarios
 - ◆ Fixes reliance on our only forensic pathologist

Option: State Medical Examiner's Office





- → Statewide medical examiner office
 - ◆ 2 forensic pathologists hired under the Department of Health
 - ◆ Based in Casper (other placements are viable)
 - ◆ Funded through self-generated revenue
- → Montana has implemented a version of the explored system.
- → Since forensic pathologists can perform any type of autopsy, they could perform **all** autopsies in the state.


Estimated Autopsies on any Given Day








Purpose



→ Dual Federal and State roles

→ Federal role:

- Serves as the State Survey Agency on behalf of the Dept.
 of Health and Human Services for:
 - Medicare and Medicaid certification of healthcare facilities operating in Wyoming (Section 1864 SSA);
 - Certification of clinical laboratories (42 CFR 493)
- Purpose of CMS Survey and Certification program is to ensure basic levels of quality and safety for health care providers.

Purpose

20

→ State role:

- ◆ Serves as the regulatory agency for licensure to operate within Wyoming (W.S. § 35-2-901 et. seq.)
- ◆ Jurisdictional authority over fire safety and building codes for construction involving healthcare facilities
- Protects health, safety and welfare of patients (residents) in licensed healthcare facilities

Budget and positions

→ Biennial budget (BFY 23):

- ♦ \$5,417,825, of which:
 - \$1,175,727 SGF (22%)
 - \$4,242,098 FF (78%)

→ 24 positions

- **♦** Administrator
- Business Office (4 positions)
- ♦ Healthcare Surveillance (14 positions)
- Life Safety and Construction (5 positions)

Survey function



- → Health Care Surveillance section conducts surveys, investigates complaints, manages CNA/LTC Abuse Registry, provides ongoing surveyor and provider training.
- → **Surveys** can be scheduled or unannounced.
 - ◆ On-site, objective, and outcome-based
 - ◆ Types include licensure, certification, and emergency preparedness surveys.
