

PAST BILLS RELATED TO LEGISLATIVE COMPENSATION IN WYOMING

Between 2001-2022, 20 bills were either numbered or introduced to modify legislator compensation, per diem, constituent service allowance, or other benefits. Of the 20 bills, only five became law. In 2002, the Legislature increased legislator salary from \$125 per day to \$150 per day and legislator per diem from \$80 per day to \$85 per day, effective January 2005, and provided legislators with a constituent service allowance. In 2005, the Legislature provided legislators with additional monthly salary amounts during the interim, as well as salary for interim committee preparation and travel, effective January 2009. The 2005 legislator per diem from \$85/per day to \$109/per day, or actual expenses in lieu of per diem, if authorized by Management Council policy. In 2009, the Legislature enacted a bill allowing unexpended constituent service allowances to be paid in subsequent quarters and limiting the yearly constituent service stipend. Finally, in 2020, the Legislature included legislators under Wyoming's workers' compensation laws. The following **Table 1** provides a brief description and disposition of the 20 bills numbered or introduced since 2001.

2020	HB 0137	Worker's Compensation- Legislators	A bill providing worker's compensation coverage for legislators.	House enrolled act 0054

2020	SF 0068	Legislator Salary Restrictions	A bill prohibiting payments of wages to members of the legislature who are public employees.	Senate did not consider for introduction vote
2020	SF 0084	Life Insurance Plan- Legislators	A bill providing for enrollment of legislators in the life insurance plan within state employees' and officials' group insurance plan; authorizing rulemaking.	Senate failed introduction
