7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1**. W.S. 19-9-403 by creating a new subsection

1

10 (g) is amended to read:

Т	19-9-403. Pay and allowances of officers and enlisted
2	persons in active state service and state active duty;
3	worker's compensation coverage for national guard members;
4	no pension denied by reason of service.
5	
6	(g) There is created the Wyoming national guard member
7	reenlistment program. The military department shall
8	establish and administer this program for the purpose of
9	providing reenlistment bonuses to members of the Wyoming
10	national guard to increase the Wyoming national guard's
11	strength in accordance with the following:
12	
13	(i) The military department may provide a
14	reenlistment bonus of five thousand dollars (\$5,000.00) to
15	a Wyoming national guard member meeting all of the
16	following requirements:
17	
18	(A) The Wyoming national guard member
19	satisfies the Wyoming national guard's reenlistment
20	eligibility criteria;
21	

1	(B) The Wyoming national guard member
2	reenlists with the Wyoming national guard for not less than
3	three (3) years; and
4	
5	(C) The Wyoming national guard member
6	satisfies any other requirements specified by the military
7	department.
8	
9	(ii) Upon satisfaction of the requirements under
10	paragraph (i) of this subsection and to the extent
11	sufficient funds are available, the military department
12	shall distribute a reenlistment bonus of not more than five
13	thousand dollars (\$5,000.00) to the reenlisting Wyoming
14	national guard member;
15	
16	(iii) Beginning November 1, 2026 and annually
17	every November 1 thereafter, the military department shall
18	report to the joint transportation, highways and military
19	affairs interim committee on the Wyoming national guard
20	member reenlistment program. The report shall include the
21	following:
22	

1	(A) The number of Wyoming national guard
2	members who reenlisted;
3	
4	(B) The average number of years the Wyoming
5	national guard members reenlisted;
6	
7	(C) The amounts of reenlistment bonuses
8	<pre>paid;</pre>
9	
10	(D) The total number of members in the
11	Wyoming national guard including the percentage of increase
12	or decrease in the total number of members in the Wyoming
13	national guard from the previous year;
14	
15	(E) Any recommended legislation.
16	
17	Section 2. There is appropriated one million dollars
18	(\$1,000,000.00) from the general fund to the Wyoming
19	military department for purposes of funding the Wyoming
20	national guard member reenlistment program as created by
21	this act. This appropriation shall be for the period
22	beginning with the effective date of this act and ending
23	June 30, 2028. This appropriation shall not be transferred

1 or expended for any other purpose and any une	, xpended
---	-----------

- 2 unobligated funds remaining from this appropriation shall
- 3 revert as provided by law on June 30, 2028. It is the
- 4 intent of the legislature that this appropriation not be
- 5 included in the standard budget for the Wyoming military
- 6 department for the immediately succeeding fiscal biennium.
