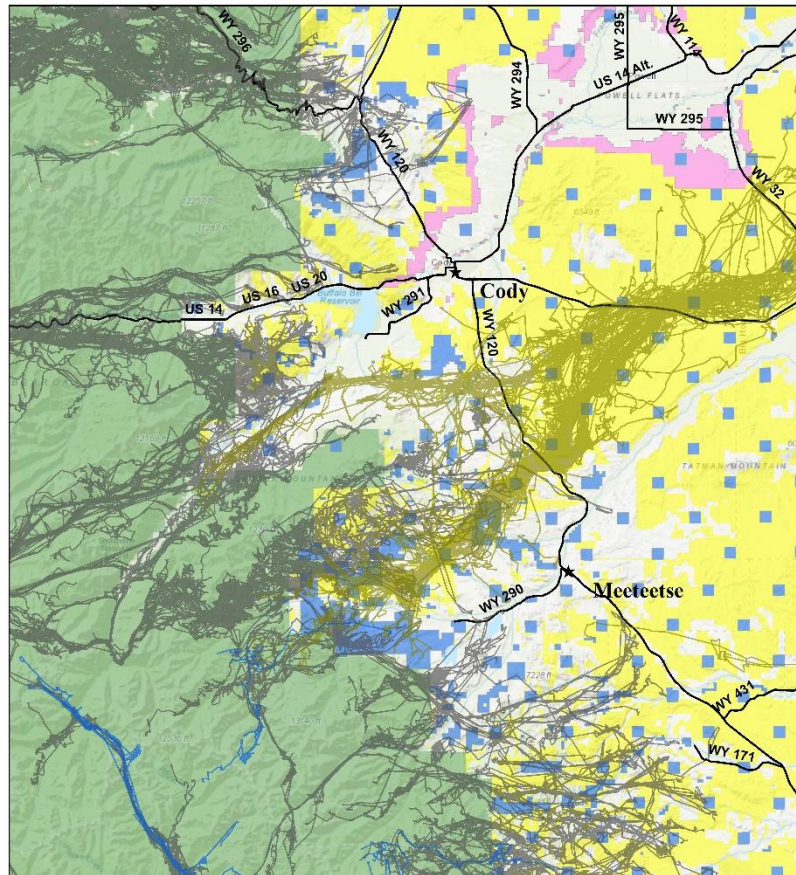

High risk of catastrophic fire adjacent to residential areas
